Secretary.

• The search for a secretary secondment continues with those approached declining. Various discussion and more names suggested.

Sailing Master

Technical.

- Progress is being made regarding the IRSA Management problems and GA is underway.
- IOMICA to follow WS and IOC decisions to suspend the participation of Russian and Belarusian sailors and officials from taking part in any competitions sanctioned by IOMICA until further notice.
- IRSA are considering a proposal to allow boat contact when rounding course marks excluding the start/finish marks.

Voting.

We received a total of 18 valid votes, all unanimously approving the financials, fees etc. On the basis of there being approximately 270 IOM members, 18 votes is 7% which is very disappointing. Discussion around how we can increase participation in voting. Perhaps the NZRYA voting immediately prior to the NCA votes resulted in members thinking they had voted and perhaps we have not communicated the fact that the NZRYA and NCA are separate voting entities.
