

# Application for Affiliation as a NZRYA Member Club

This application form should be used by radio sailing clubs wishing to affiliate to the New Zealand Radio Yachting Association (NZRYA) by joining the Association as a Member Club.

#### Process

This application form should be completed and signed by officers of the club with authority enter into agreements on behalf of the club. The completed form and supporting information must be forwarded to the NZRYA Secretary:

On receipt, the NZRYA will consider the application and vote in Council on the acceptance of the club as a Member Club of NZRYA.

#### Agreement

- 2. Acting in good faith and loyally with NZRYA and its members to ensure the maintenance and enhancement of radio sailing for the collective and mutual benefit of NZRYA, the *Club* and their respective members.
- 3. Promoting mutual trust and confidence between NZRYA and the *Club* and it's respective members and at all times acting on behalf of, and in the interests of, its members.
- 4. On request, provide to NZRYA a copy of the *Club's* constitution and any proposed amendments to it, noting that the NZRYA Council may require an amendment where any existing or proposed rule is inconsistent or in conflict with the constitution, regulations, by-laws, or policies of NZRYA.
- 5. The *Club* shall maintain a register of its members and provide such register, and all details contained within it, to NZRYA as requested from time to time.
- 6. At the commencement of the NZRYA financial year, the *Club* shall join all its Club Members as Individual Members of NZRYA and pay their NZRYA subscription. (Club Member means any individual recognised by the Club as a member and having the right to participate as a member in Club organised races or other sailing events)
