NCA & DNM Memorandum Of Agreement

This MOA sets out the agreement between DF Racing New Zealand (as NCA) and the New Zealand Radio Yachting Association (as DNM) whereby NZRYA agrees to delegate to DFRacingNZ the administration of the DF65 and DF95 classes in New Zealand.

1. Abbreviations and Definitions

1.1. Abbreviations used in this MOA have the following meanings

DF65 DragonForce 65 class of Boat

DF95 DragonFlite 95 class of Boat

DFRacingNZ DF Racing New Zealand. The New Zealand NCA for DF65 and DF95 Owners.

DNM Designated National Member of IRSA. In New Zealand this is the NZRYA.

ICA International Class Association

IRSA International Radio Sailing Association

MOA Memorandum of Agreement

MNA Member National Authority of WS. In New Zealand this is YNZ.

NCA National Class Association

NZRYA New Zealand Radio Yachting Association.

WS World Sailing

YNZ Yachting New Zealand

1.2. Where the following words and phrases are used in their defined sense in this MOA, they appear capitalised and in an italic typeface.

Boat A Boat that may comply with the Class Rules.

Constitution The Constitution which records the rules of either Party as the context requires.

Class The DF65 or DF95 class of Boat as appropriate to the context.

Class Rules The DF65 Class Rules and the DF95 Class Rules shall be the latest published

revisions available from the DF Racing World Information website

(https://dfracing.world).

DFRacingNZ Event A DF65 or DF95 National Championship, Regional Championship, North or

South Island Championship or Ranking Event approved by DFRacingNZ and

authorised by NZRYA.

Effective Date The date on which both Parties have signed the MOA.

Electronic Communication A means of exchanging information including but not limited to the World Wide

Web, the Internet, e-mail, fax, telephone, Message Boards.

Good Standing A Member is in Good Standing when they have paid all applicable subscriptions,

fees and levies and have not resigned, or had their membership suspended or

terminated.

Jurisdiction The jurisdiction of the MOA covers the areas and territories administered by YNZ

as the MNA.

Member A person meeting the criteria for membership of DFRacingNZ in accordance with

the DFRacingNZ Constitution.

Notice A formal notification which may be given as an Electronic Communication.

Officer An elected Officer in terms of each Party's Constitution.

Owner A person who owns at least one DF Class Boat and is a Member of DFRacingNZ.

Party A party to this MOA, being either DFRacingNZ or the DNM.

Regulation Any rule, ruling, law, bylaw, regulation, directive, guideline, term, condition,

instruction, or policy enacted by the management committee of either Party as the

context requires.

shall/may In this Constitution, the word "shall" specifies a mandatory action or procedure,

while the word "may" is permissive.

1.3. In this MOA, unless the context requires otherwise:

1. Expressions defined in the Definitions shall have the defined meaning in the whole of this MOA;

- Clause headings and other headings are for ease of reference only and will not affect the interpretation of this Constitution;
- Any obligation not to do anything will include an obligation not to suffer, permit or cause that thing to be done;
- 4. Words importing the singular number will include the plural and vice versa;

2. Authority

- 2.1. The DNM enters this MOA having delegated authority from IRSA and YNZ for radio sailing in New Zealand and the DNM signatory is an Officer of the DNM authorised to sign on behalf of the DNM.
- 2.2. DFRacingNZ enters this MOA as the representative body for Owners of Class Boats in New Zealand and the DFRacingNZ signatory is an Officer of DFRacingNZ authorised to sign on behalf of DFRacingNZ.

3. Purpose of the MOA

- 3.1. This MOA describes and defines the cooperative relationship between the Parties in respect of supporting and administering the Class and in particular:
 - Establishes DFRacingNZ as the sole representative and administrative body for Class affairs within the Jurisdiction.
 - Specifies the authorities delegated to DFRacingNZ by the DNM.
 - 3. Specifies the ongoing responsibilities of DFRacingNZ to the DNM.

4. Scope of the MOA

4.1. The scope of this MOA includes all activities relating to the radio sailing of Class Boats within the Jurisdiction.

5. Obligations of the Parties

NCA & DNM Memorandum Of Agreement v0.3

- 5.1. DFRacingNZ shall:
 - 1. Be self-governing in accordance its Constitution, Regulations and the provisions of this Memorandum.
 - 2. Administer the Classes in accordance with the Constitution and act in the best interests of it's Members.
 - Appoint a representative to the DF ICA World Council and participate in the work of the World Council in accordance with the provisions of the DF ICA Constitution and Regulations.
 - 4. Agree to affiliate to and maintain membership of the DNM and to pay the annual Affiliation Fee.
 - Use its best endeavours to ensure that its Members individually affiliate with the DNM and comply with all relevant DNM resolutions and regulations.
 - 6. Use the approved Class insignia in class publications, advertising, or promotions and provide the DNM

with up-to-date copies of all Class publications in New Zealand.

- 7. Prepare and provide to the DNM, an annual report on the activities of the Class in New Zealand, including the attainment of DFRacingNZ objectives, current members in Good Standing and sail numbers issued. The annual report shall be provided in the month following the end of the DFRacingNZ fiscal year.
- Prepare and provide to the DNM, a complete set of annual accounts. The annual accounts shall be provided in the month following the end of the DFRacingNZ fiscal year.

9. Maintain a register of allocated sail numbers.

 Ensure that Boats competing in DFRacingNZ Events comply with NZRYA eligibility requirements and Class Rules.

5.2. The DNM shall:

1. Recognise DFRacingNZ as the sole class association for the Classes in New Zealand.

- Delegate to DFRacingNZ the authority and responsibility for the running of DFRacingNZ Events including
 - a) Establishing the sailing calendar for DFRacingNZ Events
 - b) Negotiating hosting agreements with clubs affiliated to the DNM.

3. Approve event documentation (Notice of Race and Sailing Instructions)

4. Represent DFRacingNZ interests to IRSA through NZRYA's delegate role to that organisation.

5. Provide the NZRYA website as a vehicle to promote both DFRacingNZ and the Classes.

6. Include DFRacingNZ as an insured party on any NZRYA Public Liability and Statutory insurance policies.

6. Precedence of Constitutions

6.1. Where any conflict arises between the DFRacingNZ Constitution and/or the DFRAcingNZ Regulations on the one hand and the DF ICA Constitution, the DF ICA Regulations, and/or this Memorandum of Agreement on the other, the provisions of the DF ICA Constitution, the DF ICA Regulations, and/or this Memorandum of Agreement shall prevail.

7. Commencement and Term of the MOA

7.1. This MOA will commence on the Effective Date and will continue until terminated.

8. Amendment

8.1. This MOA shall only be amended by the joint agreement of both Parties and by duly authorised signatures of the Parties to a revised MOA.

9. Suspension and Termination

- 9.1. This MOA shall be suspended during any period during which DFRacingNZ has not paid the Affiliation Fee due to the DNM. Such suspension ends with immediate effect on payment of the outstanding fee.
- 9.2. Either party may terminate this MOA by delivering 30 days Notice of the termination to the other party, if:

1. The other party materially breaches any of its obligations, under this MOA, and

- The breach continues for a period of 30 days after the injured party delivers Notice to the breaching party reasonably detailing the breach.
- 9.3. The MOA will automatically terminate in the event that either party is dissolved in accordance with its Constitution.
